KNOW ALL MEN BY THESE PRESENTS:

THAT WHEREAS, by instrument dated January 24, 1941, recorded in Volume 1110, Page 797, Deed Records, Harris County, Texas, F. M. Corzelius, individually and as Trustee No. 1, Trustee No. 2, Trustee No. 3 and Trustee No. 4, as the then owner of all of the Timber Crest Addition, an Addition to the City of Houston, Harris County, Texas, a plat of which is recorded in Volume 17, Page 48, of the Map Records of said County, created certain minimum restrictions and covenants upon the use and occupancy of all lots and tracts in said addition, and declared that such minimum restrictions, covenants, easements and conditions would be in force and effect until January 1, 1965, and that the same would be automatically extended for successive periods of ten years unless by a vote of the majority of the then owners of the lots in said addition, it was agreed to change the said covenants or restrictions in whole or in part by vote to be evidenced by written declaration signed and acknowledged by such owners and recorded in the Deed Records of Harris County, Texas, reference to such instrument and its recordation being here made for all purposes; and,

WHEREAS, by instrument dated October 30, 1964, recorded in Volume 5763, Page 435, Deed Records of Harris County, Texas, a large majority of the then present owners of the one hundred fourteen (114) lots and tracts in said Timber Crest Addition, did reaffirm, ratify, renew, and extend each and all of the restrictions, covenants, conditions and easements, as the same are set out in said instrument recorded in Volume 1110, Page 797, of the Deed Records of Harris County, Texas, save and except the first provisions of Paragraph "a" of said instrument insofar as the same provides that "No lot in this addition shall be sold, conveyed, leased or demised to any person or persons other than of the "Caucasian Race", save and except the whole of Paragraph "1" which created a "Maintenance Fund" for the maintenance of certain defined areas within

said Addition, for an additional period of ten (10) years in order that the same would be binding upon and effective upon all of said lots and tracts in said Addition until January 1, 1975, in accordance with the provision for doing so, as contained in said instrument above referred to; and,

WHEREAS, it is the desire and intention herein of the undersigned being a large majority of the present owners of the one hundred fourteen (114) lots and tracts in said Timber Crest Addition, to reaffirm, ratify, renew and extend each and all of the restrictions, covenants, conditions and easements, as the same are set out in said instrument recorded in Volume 1110, Page 797, of the Deed Records of Harris County, Texas, save and except the first provision of Paragraph "a" of said instrument and the whole of Paragraph "1" of said instrument hereinbefore referred to for an additional period of ten (10) years in order that the same shall be binding upon and effective upon all of said lots and tracts in said Addition until January 1, 1985, in accordance with the provision for doing so, as contained in said instrument above referred to;

NOW, THEREFORE, the undersigned, being a large majority of the record owners of the lots and tracts in the said Timber Crest Addition, in consideration of the benefits to be derived from said restrictions and covenants and in accordance with and in compliance with said instrument dated January 24, 1941, recorded in Volume 1110, Page 797, Deed Records of Harris County, Texas, do hereby mutually covenant and agree that each and all of the lots and tracts in the Timber Crest Addition to the City of Houston, Texas shall hence forth be subject to and bound by each and all of the restrictions, covenants, conditions and easements contained in said instrument dated January 24, 1941, recorded in Volume 1110, Page 797, Deed Records of Harris County, Texas, save and except the first provision of Paragraph "a" of said instrument and save and except the whole of Paragraph "1" of said instrument, hereinbefore referred to, all of which restrictions and conditions, save

and except those restrictions and conditions as hereinabove mentioned, are hereby reaffirmed and ratified as of the date of the execution hereof to be effective as covenants running with the land until January 1, 1985, subject to being renewed and extended for an additional period of ten (10) years as provided for on said above identified instrument dated January 24, 1941; and further, we, the undersigned, do hereby declare, covenant and agree that all of said restrictions, save and except the first provision of Paragraph "a" and the whole of Paragraph "1", as set out in said instrument dated January 24, 1941, above identified, and as above mentioned, shall be and the same are hereby renewed and extended for an additional period of ten (10) years from January 1, 1975 and agree that all of said restrictions, covenants and conditions throughout said additional period of ten (10) years from January 1, 1975 and agree that all of said lots and tracts of said Timber Crest Addition shall be subject to and bound by said restrictions, covenants and conditions throughout said additional ten (10) year period and until January 1, 1985, and each of the undersigned hereby certifies that he, she or they, as the same may be, is or are the owner or owners of the lots opposite their respective names in Exhibit "A", which is attached hereto and made a part hereof as if copied in full above.

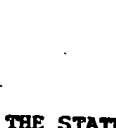
